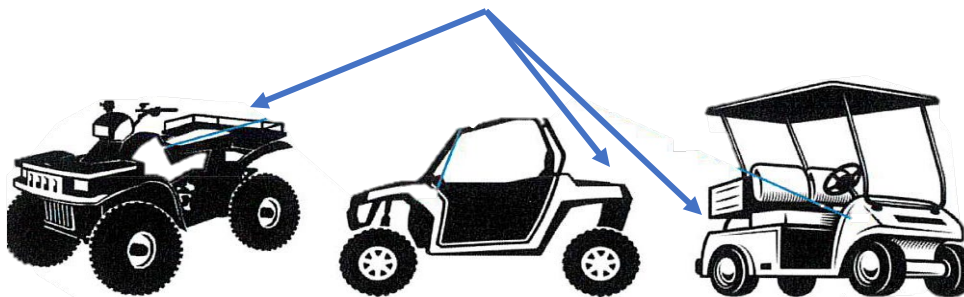

INSTRUCTIONS FOR ATV/UTV AND GOLF CART PERMIT

1. **The application fee is \$20.00.** The fee is for the permit to show law enforcement that you have registered with the City of Cottonwood and are allowed to drive within the City of Cottonwoods Roadway Limits on an ATV/UTV/Golf cart. **This fee is non-refundable.**
2. Read the attached sheets before you complete the Permit Form to avoid any potential misunderstanding later on.
3. False information on the permit form is a crime and will be handled as such.
4. Upon completing the permit form and reading the attached information, the permit sticker must be attached on your machine before operation on city streets.

Note: The abuse of the privilege to operate these machines in the City of Cottonwood can be revoked. If your privilege to operate has been revoked, you will not be issued another permit for that registration period.

Machines operated on a pavement can be dangerous. Horseplay will not be tolerated. You must use hand signals when turning or stopping on any city street unless your ATV/UTV/Golf cart has Blinkers and break lights.

Attached is a set of rules, reminders, and safety tips for operating an ATV/UTV/Golf cart in the City of Cottonwood as set by Ordinances 2010_3, 2010_4, 2020_02, and 2020_03.

Rules & Regulations per Cottonwood Ordinances

1. All permits shall expire on December 31 of the year in which the permit was issued.
2. If persons shall get a new machine mid-year, machine must be registered at the City office, but there shall not be a fee for the transfer of permit from old ATV to the new.
3. No person shall permit the operation of an ATV/UTV/Golf cart who is under sixteen (16) years of age.
4. If licensed for highway use, a license plate must be displayed on the machine.
5. Persons must show the ATV/UTV/Golf cart is insured.
6. Machines may be operated from Sunrise to Sunset, unless outfitted for streets. (headlights, signals, breaks, etc.) Machines shall not be operated in inclement weather or when visibility is impaired by weather, smoke, or fog.
7. All ATV operators and passengers under the age of eighteen (18) must wear a helmet.
8. All Golf Carts must be equipped with a Slow-Moving Vehicle Sign.
9. No driving ATV's under the influence or a controlled substance.
10. Operator must have a valid driver's license.
11. Any person operating an ATV/UTV/Golf cart without having obtained a permit from the city is guilty of a misdemeanor.
12. You must yield to the right of way to all vehicle traffic and pedestrians.
13. You must obey all regulatory signs such as stop signs, yield and speed signs.
14. It is illegal to ride in a careless manner which endangers persons or property.
15. It is illegal to operate at a speed that is unreasonable or imprudent.
16. Operation on city property such as parks and cemeteries is illegal. You must remain on paved surfaces or trails in these locations.
17. You may not ride in the ditch.
